Dear Saint Agnes Families,

Thank you for choosing Saint Agnes School for your child. Your commitment to Catholic education is very much appreciated, and we are grateful for the opportunity to serve your family in this important ministry.

In partnership with members of the St. Agnes Finance Committee, below is the tuition information for the 2025-26 academic school year. We understand that paying for a Catholic education can be a significant sacrifice so we are diligent in our efforts to ensure that Saint Agnes remains sensitive to the financial challenges of our families.

Parish donations (from the offertory collection, the endowment fund, the tithing fund, etc.) provide a significant subsidy to our school and hence to our families with children in our school. Without these subsidies tuition rates would be significantly higher.

As a reminder, per the school handbook (pg. 8), “families registered in the Saint Agnes Parish are expected to be active members of the parish.” In order to be considered active in the parish and receive the “Active Parishioner” tuition rate, families must:

- attend Sunday and Holy Day Masses;
- give service to the parish and/or school; and
- contribute to the church offertory.

If you have been active in the above criteria, your family will follow the In-Parish (active parishioner) rates. School families who do not meet the above criteria will pay the Out of Parish (full-tuition) amount. It is important to note that the Parish offertory donations subsidize the school approximately \$1,081 per student or ~\$380K annually. Without our parishioners, the school would not be able to sustain itself.



The FACTS Management Company will help us manage our tuition payment program and will be made by ACH or credit card through the FACTS Management Company program. The following tuition payment plans are available:

1. Full tuition in one payment by September 2, 2025.
2. Tuition in two payments, half by September 2, 2025 and the balance by January 1, 2026.
3. Quarterly payments on August 1, 2025, November 1, 2025, February 1, 2026, and May 1, 2026.
4. Eleven monthly payments due on either the 5<sup>th</sup> or 20<sup>th</sup> of each month beginning in July, 2025.

**NOTES:** *For payments made by American Express, VISA, MasterCard, or Discover credit card, FACTS charges a 2.95% convenience fee for each payment.*

*FACTS charges a \$30 NSF fee each time a payment is unable to be processed.*

Please remember, if you choose the ACH payment plan, you will authorize automatic bank payments directly from your bank account. Be assured that neither FACTS nor the school will have direct access to or any knowledge about the status of your bank account. It is simply a pre-authorized bank-to-bank transfer of funds.

Please also be advised, **if a FACTS account becomes inactive** once tuition payments become due, new banking information needs to be established within 14 days or the total remaining tuition becomes due within 7 days. If the full payment is not made or an active FACTS account is not established, your child/children will not be able to attend school until the matter is resolved.

Current school families have been automatically re-enrolled in the FACTS program for the 2025-2026 school year with the same payment plan as the current school year. If you would like to change your payment plan, you must speak with a FACTS representative at 1-866-441-4637. Please note that if you have changed or will change your financial information (bank or credit card) on your current FACTS agreement after April 1, 2025, you will need to also change it on the agreement for the 2025-2026 school year once the agreement is finalized in May.

New school families will need to enroll in the FACTS program by going to <https://online.factsmgt.com/signin/3FTL2>. The account should be set up as soon as possible but no later than June 1, 2025.
